

## ELIOT HISTORICAL SOCIETY – Minutes of the Meeting – November 4, 2019

Paul Johnson called the meeting to order at 7:00pm. Paul confirmed the schedule for the evening, with the Program to be followed by refreshments and then the Business Meeting. Every month we have a fudge raffle– 2 winners will be picked at the end of the evening. EHS is non-profit and donations are always welcome.

### Officers Report

**Secretary Report:** Tracey Graffam read the minutes of the October meeting which were accepted and approved with one correction.

**Treasurer's Report:** Pam Ashley presented the treasurer's report which was accepted with no corrections.

### Committee Updates

**Correspondence:** Helen sent a get-well card to Ruth Drake.

**Membership:** Sylvia confirmed that we have new lifetime members the family of Gene and Stacey Wipyski.

**Programs:** Carolyn Bough confirmed for that the next month's program is a fun evening where all are invited to bring in something they would like to share from the past. If you do not have something to show, you are invited to share a story on your favorite Christmas gift you have received or something similar.

**Building:** Paul confirmed there is now power in the shed out the back.

**PR/Publicity:** Carolyn confirmed that as of December, she will no longer be serving in her current capacity for PR/Publicity or Programming.

### **Program**

Carolyn Bogh introduced Paul Gorranson who led a presentation on the restoration of the 1700 barn on their property. Paul shared the details of the restoration project of the barn on the program. The project started in 2017 and was completed in May 2019. Paul shared history of the owners of the barn which included James Bartlett c. 1870 and Nathan Bartlett of the 1740s. Paul confirmed that the original Heard Garrison is one of the oldest structures in Eliot. The Bartletts moved into the area and married into the Heard Family in the 1700s. There was an earthquake that destroyed many buildings in Eliot. In in 1930s, Burt Irving took over and used the lands for cows. The Irvings sold the property to Boardman's from Concord, which served as they beach house. From there the house sold from the Boardmans to the Thomsons – Kay Thompson – managed the property until they sold in 2001. In 2017, the property was then sold to Paul and Wife. Many had questions for Paul on the techniques used during the restoration. All enjoyed the program very much and shared their appreciation to Paul. The program ended at 7:50pm and was followed by refreshments and the business portion of the meeting.
